Rowles, of the town of Monticello, and Territory of Florida, merchant, being sick and weak in body, but of sound mind, memory and understanding, (praised be God for it,) and considering the certainty of death, and the uncertainty of the time thereof; and to the end I may be better prepared to leave this world, whenever it shall please God to call me hence, do therefore make and declare this my last will and testament, in manner following, (that is to say;)

It is my will that all my just debts and the charges of my funeral be paid and discharged, by my executrix hereinafter named and appointed, out of my estate, as soon as conveniently may be after my decease, and I leave the charges of my funeral to the direction of my said executrix.

I give, devise, and dispose of all my estate real, personal and mixed, (save what shall be necessary for the payment of my just debts and funeral charges,) in the following manner:


I give and grant to my beloved wife, Mary Catharine Rowles, two-thirds of all my estate real, personal and mixed, legal and equitable, situated and being in the town of Monticello, Territory of Florida aforesaid, and in the county of Fairfax, State of Virginia; and two-thirds of all other estate real, personal, and mixed, legal and equitable, wheresoever situated or being, to which I now have, or may at any time hereafter have, right, title or claim, by gift, grant, devise or otherwise, to have and to hold the same to the said Mary Catharine and her heirs, in fee-simple and full disposal forever. Which gift and grant I make to the said Mary Catharine, upon condition, that she accept the same in full other right of

dower in my estate, and shall give, when demanded by those authorised in law to receive it, a release of all demands and claims of dower and otherwise; of and against my estate, save what I have herein given to her.

I give and grant to my brother, John F. Higgs, the remaining one-third of all my estate real, personal and mixed, legal and equitable, situated and being in the town of Monticello Territory of Florida aforesaid, and in the County of Fairfax, State of Virginia; and the remaining one-third of all other estate real, personal and mixed, legal and equitable, wheresoever situated or being, to which I now have, or may at any time hereafter have, right, title or claim, by gift, grant, devise or otherwise, to have and to hold the same to the said John F. Higgs and his heirs in fee-simple and full disposal forever.

And I do hereby nominate constitute and appoint my beloved wife, Mary Catharine Rowles, to be executrix of this my last will and testament.

In witness whereof I hereto put my hand and seal, and publish and declare this to be my last will and testament, this seventh day of July A.D. eighteen hundred and forty one.
